## **Academic Writing, Publishing and Presenting**

## One week

As science is becoming truly international, researchers are faced with challenges of publishing in established international journals, and adhering to international research and ethical standards. Developing a strong publication and citation track-record is a major challenge for all scientists. This intensive course is designed to develop your academic writing, publishing, oral presenting and science communication skills.

The course is administered through seminars, workshops and practical exercises, and includes the following six modules:

- Academic writing
- Publishing in international journals
- International co-authoring and grant applications
- Oral conference presentation
- Public speaking and presenting to non-expert audiences
- British cultural studies

### Business and Law

With business becoming increasingly globalised and competitive, applications of law and psychology to international business, as well as developed advocacy skills, are of utmost importance. The course is particularly suited to law and business students, legal and business practitioners, and everyone with an interest in international business.

Our International Business and Law courses are practice-oriented and are designed to equip you with practical knowledge of the laws of international business, including international contracts, international commercial litigation and cross-border commercial finance (asset-based lending): advocacy skills - court room, arbitration and written; as well as good knowledge of international commercial arbitration. The courses also touch on US commercial laws. They are enriched with psychological insights (occupational psychology) and knowledge of the British culture, to best develop your ability to successfully conduct business internationally.

- Provides you with a solid foundation of various aspects of international business law focusing on international contracts (including negotiations); the International Sale of Goods; international dispute resolution (court); and UK legal systems
- Introduces you to commercial finance cross-border asset-based lending

- Introduces you to different relevant occupational psychology topics (different to those covered in the International Business and Law I course)
